2021 Division of Policing Award Winners

Distinguished Scholar Award



William (Bill) Terrill is an Associate Dean in the Watts College of Public Service and Community Solutions, and a Professor in the School of Criminology and Criminal Justice, at Arizona State University. He earned his B.S. from Penn State Harrisburg and his M.A. degree and Ph.D. from Rutgers Newark. Over the past 25 years, Bill's research has centered on police attitudes and behavior with

an emphasis on use of force and culture. He recently completed a U.S. Department of Homeland Security grant in partnership with the Federal Law Enforcement Training Centers (FLETC) examining body-worn camera video footage to help identify escalation and de-escalation in relation to police use of force behavior. Presently, he is conducting several

projects with the Phoenix, Arizona Police Department, including a study on officer perceptions of firearm danger, an assessment of the agency's newly revised use of force training modules, and as project lead on an advisory team working to ensure use of force data are publicly accessible and transparent. Finally, Bill serves as Co-Editor for *Policing: A Journal of Policy and Practice*.

Early Career Award



John Shjarback is an assistant professor in the Department of Law and Justice Studies at Rowan University. He earned his Ph.D. in Criminology and Criminal Justice from Arizona State University in 2016. He has published close to 30 peer-reviewed articles, book chapters, and technical reports on topics broadly related to transactional violence between police officers and citizens, race/ethnicity, and accountability. Additionally, he is a proponent of public/

translational criminology and he has written op-ed essays geared towards the general public for *The Washington Post*, the *New York Daily News*, *The Dallas Morning News*, and *Smerconish.com*, among other media outlets. He has collaborated with a number of law enforcement agencies and practitioners on various projects and evaluations, and his research has impacted policy and informed data collection efforts. For example, his work on use of force and officer-involved

shootings has been cited during legislative and agency efforts in Philadelphia, Utah, Georgia, and New Jersey. John has also provided testimony regarding best practices for civilian oversight bodies for the New Jersey State Legislature.

Outstanding Practitioner Award




Detective Inspector Mike Newman has served with the Queensland Police Service for 29 years. He is currently the Manager of Cyber Crime Investigations, Crime and Intelligence Command. Mike has served in numerous capacities in the QPS including operational roles as a Detective, Officer in Charge of a Tactical Crime Squad and manager of crime intelligence. He has also

performed a variety of corporate roles as a support officer, the manager of training units and as a Visiting Fellow at the University of Queensland. Mike has been involved with evidence-based policing (EBP) since 2014 when he was the project manager for the Mobile Police Community Office and other projects. Since then, he has championed EBP within the QPS and other policing

agencies through the Australia and New Zealand Society of Evidence Based Policing where he has sought to foster organisational partnerships and engagement with researchers to deliver substantive research that changes or validates policing responses to victims, communities and crime.

Outstanding Book Award



Ross Deuchar, Vaughn Crichlow, and Seth Fallik's *Police-Community Relations in Times of Crisis: Decay and Reform in the Post-Ferguson Era* tells the story of policing efforts after high profile shooting death of Michel Brown. The death of Michael Brown at the hands of a white Ferguson police officer has uncovered an apparent legitimacy crisis at the heart of American policing. Some have claimed that de-policing may have

led officers to become less proactive.

How exactly has the policing of gangs and violence changed in the post-Ferguson era? This book explores this question, drawing on participant observation field notes and in-depth interviews with officers, offenders, practitioners, and community members

in a Southern American state.

As demands for police reform have once again come into focus following George Floyd's death, this crucial book informs future policing practice to promote effective crime prevention and gain public trust.

Division Virtual Forum on the Job Market

On Friday, September 17th, 2021, the Division sponsored the *Virtual Forum on the Job Market*. Janne Gaub, Executive Board member, and Alexis Rockwell, student representative, created, organized, and moderated the forum. The forum included 5 different panels on different aspects of the job market.

The first panel of the day, *Perspectives from the Search Committee*, included individuals who have either served on or chaired academic job search committees. The panelists included Drs. Melissa Morabito, Jason Ingram, William King, and Belen Lowrey-Kinberg.

The next panel, *Preparing for the Tenure Track*, provided insights on how to prepare for the tenure track for later-career Ph.D. students and early career scholars. The panelists included Drs. Thomas Mrozla, Marthinus Koen, Kyle McLean, Sherah Basham, and Thaddeus Johnson.

The *Interviewing Before and During COVID-19* panelists discussed their experiences on the job market, particularly interviewing, depending on when they were on the job market. Those with the 'before' perspective discussed in-person

interviewing and campus visits. Those with the 'after' perspective explained their experiences with video conferencing and navigating an online presence. This attendees for this panel heard from Drs. Elias Nadar, Kathleen Padilla, John Shjarback, and Natalie Todak.

The *Jobs Outside Academia* panelists were Drs. Daniel Lawrence, Shelley Hyland, Kwan-Lamar Blount-Hill, and Ms. Carlena Orosco. This panel's discussion focused on applying for and working within agencies outside of academia.

The final panel of the day was a workshop on *Application Documents*. Panelists Drs. Lin Huff-Corzine, Justin Nix, Rachel Lautenschlager, Rob Tillyer, and Rick Moule provided actionable steps for attendees to use for their documents to best prepare them for the job market.

In total, there were over 80 attendees. The forum was a great success, and the DOP is planning additional virtual panels in the future. More information to come. **We would like to thank the division members who volunteered to serve as panelists** and the DOP executive board for their assistance in this first virtual forum.
